VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY THE CHAIRMAN AND CONTROLLING SHAREHOLDER

The announcement is a voluntary disclosure made by Tianyun International Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) was informed that on 25 August 2016, Mr. Yang Ziyuan (“**Mr. Yang**”), the chairman and controlling shareholder of the Company, through Wealthy Active Limited, acquired on the market an aggregate of 500,000 shares of the Company, representing 0.05% of the entire issued share capital of the Company as at the date of this announcement, at a total consideration of approximately HK\$0.43 million.

Immediately after the aforesaid acquisitions, Mr. Yang’s shareholding in the Company increased from approximately 44.62% to approximately 44.67%.
