#### **VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING BY THE CHAIRMAN AND SUBSTANTIAL SHAREHOLDER**

The announcement is a voluntary disclosure made by Tianyun International Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) was informed that on 19 July 2021, Mr. Yang Ziyuan (“**Mr. Yang**”), the chairman and substantial shareholder of the Company, through Wealthy Active Limited, acquired on the market an aggregate of 500,000 shares of the Company, representing approximately 0.05% of the entire issued share capital of the Company as at the date of this announcement, at a total consideration of HK\$774,640.

Immediately after the aforesaid acquisition, Mr. Yang’s shareholding in the Company increased from approximately 19.96% to approximately 20.01%.
